understand that this sporting event carries potential life threatening danger, serious injuries, and property damage. The primary risks and property or non-property damages may be caused by, but are not limited to: the terrain, constructed routes, accidental objects, equipment, personal physical condition, weather conditions, fires, vehicle traffic, or by actions of third parties such as participants, volunteers, spectators, officials, organizers, and sponsors. These risks apply both to competitors and volunteers participating in the sports event/competition. By signing this declaration, I state that:

1. I am familiar with the general terms (available on the website <https://tepejambore.com>) of the event Tepe Jamboree on June 15, 2024, and I acknowledge all risks for my participation in it as a participant/competitor or volunteer;
2. I am aware that I may suffer property or non-property damages due to the negligence and irresponsibility of third parties, dangerous or defective equipment or property managed and controlled by third parties, or by unintentional human error, domestic or stray animals, motor vehicles, bicycles.
3. I am physically healthy, possess the necessary skills to participate in the competition, and my actions do not contradict medical advice;
4. I agree that this Liability Waiver may be used by the organizers and sponsors of the event in which I am participating and declare that I am responsible for my actions (intentional or negligent) during the sports event/competition;
5. As a registered participant in the sports event/competition, this liability waiver binds me, my family, relatives, and heirs.
6. I undertake to unconditionally comply with all decisions and orders of the organizational team, authorized volunteers, and responsible persons at any moment during the event/competition, regardless of whether they concern the organization of the event or my personal participation in it.
7. I agree to release from liability the organizers from the non-profit association OBSTO BUDESHIE with BULSTAT 176780073, sponsors, spectators, volunteers, and other participants for events causing harm to my physical body such as, but not limited to: death, disability, physical injuries, bodily harm caused by or to me, property damage, and

other incidents that may occur during the event/competition or on the way to the event/competition venue;

8. I agree that the persons and entities described in item 7 are released from liability for claims or other types of demands and complaints by third parties for incidents and damages caused by my intentional or negligent actions during the event/competition.
9. With this declaration, I consent to receive medical assistance in case of injury, trauma, or illness occurring during the event/competition, to be transported by ambulance, and I am aware that some of these activities may incur fees.
10. I am aware that some of the risks described above may be insurable.

The liability waiver applies within the legal provisions of the legislation of the Republic of Bulgaria. I declare that I have read and understand the contents of this declaration.
